

Privacy Statement VCA.nl and SSVV.nl

In this privacy statement, we describe the personal information that we collect when you use our website, why we collect this information, and what we do with it. We think it is important that your personal details are handled carefully, and we will make sure that any personal information you issue to us is handled in a confidential way.

In short, this privacy statement means your personal data:

- will only be used for the purposes that you have agreed to;
- will not be shared with others, unless this is necessary for the performance of our services or activities;
- will be protected carefully.

If you have any questions about issues that are not covered by this privacy statement, suggestions or comments concerning its contents, or complaints about the way in which we process your personal details, then you can contact us at any time. You will find our contact details at the bottom of this document.

This privacy statement is applicable to all websites of the Stichting Samenwerken Voor Veiligheid (Foundation Cooperation for Safety, SSVV). The SSVV is not responsible for the privacy policy of other websites and sources that are named on our websites.

Purposes

We do not collect or use your personal details for any other purposes than those described in this privacy statement unless we have obtained your consent for such beforehand.

Use of our services

If you make use of our services, we can ask you to provide certain personal details. These details are necessary so that we can provide you with the relevant service or product, and they will be stored by SSVV in accordance with the statutory duty of retention.

Communication

If you send us emails or other messages, they will be saved in our administrative systems and stored in accordance with the statutory duty of retention. Sometimes we might ask you to provide personal details so that we can answer certain questions you might have or to comply with certain requests you have made.

Forms

The website contains forms that you can use to make a request or download information, to sign up for the newsletter, to place orders, to enter into agreements, or to contact us. The details that you issue to us in these forms will be kept for as long as necessary or reasonable in order to answer your questions or to



process your requests. Your requests can moreover be filed in our administrative systems and stored in accordance with the statutory duty of retention.

Third party

We make use of third parties for the performance of our services and activities. If these third parties are given access to your details as a result, we will take appropriate measures to ensure your details are properly protected and are only used for the intended purposes. The SSVV will never sell your personal details to third parties.

Data protection

The SSVV has taken appropriate technical and organisational measures to protect the personal details provided by you from unlawful use.

Your details will be sent via secure links over the internet, and will be processed and stored on the servers of the SSVV in certified data centres. The personal details will be hidden from search engines.

Our employees have a legal obligation to safeguard the confidentiality of your details. This obligation is also contractually imposed on any third parties that we hire for the performance of our services and activities.

Website visits

If you visit our website, the technical details of your visit will be recorded in so-called log files. These details can include information about the page you have visited, your IP address, the date of your visit, and the browser you used. We do not track which IP address was used at which moment, and we therefore do not use these details to identify you personally. These log files are stored for analysis purposes only.

Cookies

Cookies are small text files that your browser saves on your computer. Read more about cookies and the applicable regulations (in Dutch) at https://www.consuwijzer.nl/veilig-online/cookies.

This website makes use of functional cookies that are necessary in order to make the website function properly. In addition, we can also use cookies to analyse the usage of our website and to enhance the user experience.

Events and meetings

Photographs and videos can be taken during the events and meetings of the SSVV. These photos or videos can be published on the websites or social media accounts of the SSVV. By visiting an event, you agree to this.

Social media and links to other websites

The website includes buttons so you can follow the SSVV via social media. The code that is used for these buttons comes from the relevant social media organisations. This code can include, amongst other things, the placing of a cookie (see above). We have no control over this, and you should therefore see the



privacy statements of the relevant social media organisations in order to find out what they do with the (personal) data that is collected via these cookies.

The website can also include links to websites of third parties. Although these websites have been carefully selected, the SSVV accepts no responsibility for these third parties or the way in which they use (personal) data.

Reviewing and updating of personal data

You have the right to ask us what personal details we have collected about you and saved in our databases. If you think these personal details are not or no longer correct or complete, then you can ask us to update, rectify, or erase your personal details. Before we handle such a request, we will first have to verify the identity of the applicant in connection with the protection of your personal details. We will carry out a change request as quickly as possible. If we cannot carry out your request (yet), then we will tell you the reason why not.

Changes

This privacy statement has been drawn up based on the current usage and features of this website. Changes to this website can lead to changes in this privacy statement. We would therefore advise you to check this privacy statement regularly.

Exceptions

Notwithstanding the exceptions provided for above, the SSVV will only disclose your personal details to third parties if it has a legal obligation to do so.
